CITY COUNCIL MEETING MINUTES
January 8, 2024

BE IT REMEMBERED that the Council of the City of Lebanon, Missouri, met in Regular Session on January 8, 2024 at 6:00 p.m. in the Council Chambers at City Hall located at 401 South Jefferson.

ROLL CALL AND DECLARATION OF A QUORUM

Upon roll call, the following Officers were present: Gib Adkins, Mike Evans, Sheila Mitchell, Dan Mizell, Randy Wall, Chuck Jordan, Bob Garner, and Mayor Carr. Absent: Jeff Mutchler.

A quorum was declared.

Mitchell moved and Mizell seconded that Council move out of Regular Session and into Public Hearing. Motion carried as follows: Yea: (6) Evans, Mitchell, Mizell, Wall, Garner, and Adkins; Nay: (0) None; Abstain: (1) Jordan; Absent: (1) Mutchler.

Replat of Lots 1, 2, and 3 of Finch View Subdivision

Code Administrator Joe Berkich shared that this location was located at New Buffalo Road and in order to clean up the property lines between two neighbors, the owners wished to replat from four lots into three lots, adding that the Replat was approved by Planning and Zoning.

Rezoning of the 400 Block of Texas Avenue from M-1 Industrial to RS-2 Residential

Code Administrator Joe Berkich reported that this is located next to the Ice Cream Factory and in order to construct some residential dwellings on the empty land, it had to be rezoned.

COUNCIL BILL NO. 6611- REZONING OF LOT 1 AND LOT 2 OF FINCH VIEW SUBDIVISION FROM RS-1 RESIDENTIAL TO RS-2 RESIDENTIAL

An Ordinance by the City Council of the City of Lebanon, Laclede County, Missouri, amending the City of Lebanon, Missouri, Zoning District Map by approving the Rezoning of Lot 1 and Lot 2 of Finch View Subdivision from RS-1 Residential to RS-2 Residential; fixing the effective date thereof; repealing ordinances or parts thereof in conflict.

Mitchell moved and Mizell seconded that the Council approve the second and final reading of Council Bill No. 6611 and that the roll be called for the approval and passage of said bill. COUNCIL BILL NO. 6623- AMENDING CITY CODE OF ORDINANCES CHAPTER 2 ADMINISTRATION ARTICLE VI FINANCE DIVISION 2 PURCHASING

An Ordinance by the City Council of the City of Lebanon, Laclede County, Missouri, (hereinafter referred to as "City") amending the City Code of Ordinances Chapter 2 Administration Article VI Finance Division 2 Purchasing.

COUNCIL BILL NO. 6628- REZONING OF THE 400 BLOCK OF TEXAS AVENUE FROM M-1 INDUSTRIAL TO RS-2 RESIDENTIAL

An Ordinance by the City Council of the City of Lebanon, Laclede County, Missouri, amending the City of Lebanon, Missouri, Zoning District Map by approving the Rezoning of the 400 Block of Texas Avenue from M-1 Industrial to RS-2 Residential; fixing the effective date thereof; repealing ordinances or parts thereof in conflict.

Mitchell moved and Evans seconded that the Council approve the first reading of Council Bill No. 6628 and that it be passed to the second reading. Motion carried as follows: Yea: (7) Garner, Adkins, Evans, Mitchell, Mizell, Wall, and Jordan; Nay: (0) None; Abstain: (0) None; Absent: (1) Mutchler.

The second reading is scheduled for January 22, 2024.

COMMENTS

Finance Director Kat Gill reported she had handed all Council members the official copy of the completed audit.

Interim Police Chief Lt. Matt Wright thanked Council for their support for the purchase of the vests for the Police Department.

Public Works Director Richard Shockley shared the Street Department was ready for the potential winter weather.

Councilman Adkins shared he liked was impressed with the new sound system in the Chambers and he looked forward to the new year.

Mayor Carr shared that 2023 was a great year and the Council meeting on January 22nd would be longer due to the number of items being addressed. Mayor Carr also relayed that Work Session would be on February 12th and February 26th, with the Budget in May and the Retreat in October.


ADJOURNMENT
