CITY COUNCIL WORK SESSION MINUTES  
February 12, 2024

BE IT REMEMBERED that the Council of the City of Lebanon, Missouri, met in Work Session on February 12, 2024, at 6:00 p.m. in the Council Chambers at City Hall located at 401 South Jefferson.

**ROLL CALL AND DECLARATION OF A QUORUM**

A quorum was declared.

**GROUP 2 GOALS- INFRASTRUCTURE AND UTILITIES**

Public Works Director Richard Shockley presented information related to the goals set for the Infrastructure and Utilities Goals Group. He spoke about the status of survey and engineering plans related to the improvements of the Jefferson and Fourth Street intersection and improvements to the Jefferson and Fremont intersection. Shockley also reported that the 1-44 to North 5 Loop remained on MoDOT's Tier II unfunded projects list. During his presentation, he also spoke about street maintenance, improvements to the sidewalk network, maintenance of street right-of-way, the status of stormwater solutions funded by grants, and training and enhanced reliability of utilities.

**ROUND TABLE DISCUSSION**

Councilman Evans- commented about the problem of semi-trucks and trailers parking on city streets and provided the names of several streets where he had seen this violation.
