BE IT REMEMBERED that the Council of the City of Lebanon, Missouri, met in Regular Session on February 12, 2024 at 7:07 p.m. in the Council Chambers at City Hall located at 401 South Jefferson.

COPE Check Presentation

Mayor Carr presented COPE's Executive Director Judy Kile with a check in the amount of \$2233.50. The funds represented money collected from court fines for domestic violence shelters as authorized by state statute.

Ronald McDonald House Week Proclamation

Mayor Carr read the following proclamation aloud for which he proclaimed February 12th through February 18th, 2024, as "Ronald McDonald House Week."

Final Plat of Tabone Addition

Planning and Zoning Manager Christina Wagner reported that the property owner requested a replat to create one lot out of two for development purposes at 190 Lee Street.

There were no public comments.

Final Plat of Hartman Subdivision

Planning and Zoning Manager Christina Wagner reported the property owner requested to plat Lebanon Acreage for the purpose of turning 3 lots into 5 lots at 20750 Ostrich Drive.

There were no public comments.

Final Plat of Oakwood Estates

Planning and Zoning Manager Christina Wagner reported the property owner wished to plat Lebanon Acreage known as the Oakwood Trailer Park located at 2804 Morgan Rd.

There were no public comments.

Amended Replat of Lot 15 Phase 1 Twin Valley Estates

Planning and Zoning Manager Christina Wagner reported this replat of 15A and 15B of Twin Valley Estates at 1412 and 1414 W Madison Avenue would correct an error found in the street radius of the previously adopted plat.

There were no public comments.

Review of the Appeal Request of the Zoning and Planning Commission's Decision for a Conditional Use Request to Operate a Short-Term Rental at 337 Lasalle St.

Code Administrator Joe Berkich spoke to the request for a conditional use permit at this location. He reported the request was presented to the Planning and Zoning Commission and failed with a vote of 6-1. Berkich said the property owner was now exercising his right to appeal. Mayor Carr then opened the floor to the public to speak for or against the matter.

Adam Bartholomew- as the owner of the property, Bartholomew spoke in favor of the conditional use permit request and said those who spoke against it at the Planning and Zoning meeting were ill informed. He stated that short-term rentals were gaining popularity due to the lack of lodging choices in the area and provided additional justification as to why he thought the City Council should overturn the decision of the Planning and Zoning Commission.

Pat Brown- stated he lived next door to 337 LaSalle and had experienced people walking across his yard and slamming car doors late in the evening. He stated his opposition to the short-term rental saying he considered it a safety threat to the neighborhood.

Jackie Haffer- said she was very vested in the neighborhood and chose the area to live in following her retirement. She also mentioned there was only one way in and one way out of the neighborhood and was concerned about increased traffic and the safety of those living there. She asked the Council to strongly consider upholding the decision of the Planning and Zoning Commission.

Joe Frazier- stated he felt commercial businesses shouldn't be allowed in a residential neighborhood.

Councilwoman Mitchell- stated she liked the new sound system and equipment in the Council Chambers.




