CITY COUNCIL WORK SESSION MINUTES
March 11, 2024

BE IT REMEMBERED that the Council of the City of Lebanon, Missouri, met in Work Session on March 11, 2024, at 6:00 p.m. in the Council Chambers at City Hall located at 401 South Jefferson.

ROLL CALL AND DECLARATION OF A QUORUM

GROUP 4 GOALS- INTERNAL SERVICES

IT/Airport Director Jarrad Schomaker spoke on behalf of the Internal Services group and shared the status of their goals set by City Council. He said many of the goals were pending until the new ERP software was up and running. However, he touched on the expansion of the Downtown Business District, projects that had been completed by Facilities such as roof installations on pump houses and the Wallace building, floor polishing and painting at Fire Stations #1 and #2, a new social media campaign focusing on recruitment for the Police Department, and the continuance of building a presence at Fort Leonard Wood through the Transition Assistance Program.

CIVICPLUS AUDIO/VISUAL UPDATE

Communications Manager Derek Gean provided details regarding the recent technology upgrades made in the Council Chambers, which included a new sound room, sound system, monitors, and microphones. He also shared that the City was going to start streaming the City Council meetings beginning with the April 8th meeting. In closing, Gean briefly spoke about a new community engagement tool that would be presented to Council for consideration called Citibot.

ROUND TABLE DISCUSSION

Councilman Jordan- announced that a benefit was being held at the VFW for the wife of retired police officer Steve Greek who had cancer.

CLOSED SESSION




Council moved into Closed Session at 6:16 pm and returned to Work Session at 6:35 pm.
