CITY COUNCIL MEETING MINUTES  
June 10, 2024

BE IT REMEMBERED that the Council of the City of Lebanon, Missouri, met in Regular Session on June 10, 2024 at 6:30 p.m. in the Council Chambers at City Hall located at 401 South Jefferson.

RESOLUTION NO. 507- ADOPTION OF THE SEMIQUINCENTENNIAL COMMISSION TO BE KNOWN AS "AMERICA 250 COMMISSION" TO PLAN AND ORGANIZE THE COMMEMORATION OF THE 250<sup>TH</sup> ANNIVERSARY OF THE UNITED STATES OF AMERICA IN 2026

Evans moved and Garner seconded that the Council approve Resolution No. 507 as presented.

"A RESOLUTION BY THE CITY COUNCIL OF THE CITY OF LEBANON, LACLEDE COUNTY, MISSOURI, ESTABLISHING A SEMIQUINCENTENNIAL COMMISSION, TO BE KNOWN AS "AMERICA 250 COMMISSION" TO PLAN AND ORGANIZE THE COMMEMORATION OF THE 250<sup>TH</sup> ANNIVERSARY OF THE UNITED STATES OF AMERICA IN 2026.

*WHEREAS*, that on July 4, 2026, the United States will commemorate and celebrate the 250<sup>th</sup> anniversary of the signing of the Declaration of Independence on July 4, 1776, and it is vital to begin preparations for such a momentous celebration; *and*

*WHEREAS*, that this historic milestone is an opportunity to pause and reflect on our nation's, state's, and municipalities' past, honoring the contributions of all Americans, and look ahead toward the future we want to create for the next generation and beyond; *and*

*WHEREAS*, that the United States Congress established the U.S. Semiquincentennial Commission in 2016 to plan and orchestrate the 250<sup>th</sup> Anniversary celebration, and on July 6, 2023, Missouri Governor Mike Parson, signed and put in effect Senate Concurrent Resolution No. 7 establishing the America 250 Missouri Commission to commemorate the celebration.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF LEBANON, LACLEDE COUNTY, MISSOURI, AS FOLLOWS:

SECTION 1: That the City Council of the City of Lebanon, Laclede County, Missouri, hereby establishes the Semiquincentennial Commission, to be known as "America 250 Commission" to plan and organize the commemoration of the 250<sup>th</sup> Anniversary of the United States of America on July 4, 2026.

SECTION 2: That the number of members of the Semiquincentennial Commission shall be determined by the Mayor, and the Mayor, with approval of the City Council, shall appoint members to serve the lifetime of the Commission, provided that if any member vacancy is created, all vacancies shall be filled in the same manner as originally appointed.

SECTION 3: That this Commission shall dissolve on December 31, 2026.

Councilman Jordan- shared he had attended the recent Lebanon Drug Treatment Court graduation and expressed that Council voting to help fund this program with the City's opioid settlement money was a good decision.

Councilman Garner- announced that Mel's on Madison would be holding another Celebrity Bartender event to raise money for the Hughes Center.

Mayor Carr- echoed Councilman Jordan's remarks about the Lebanon Drug Treatment Court and added it was very inspiring. He shared that he had attended First Friday and the event was packed. Mayor Carr concluded by providing the upcoming meeting schedule.
