CITY COUNCIL MEETING MINUTES  
June 24, 2024

BE IT REMEMBERED that the Council of the City of Lebanon, Missouri, met in Regular Session on June 24, 2024 at 6:30 p.m. in the Council Chambers at City Hall located at 401 South Jefferson.

Laclede Industries 50<sup>th</sup> Anniversary Proclamation

COUNCIL BILL NO. 6698- APPROVAL, REZONING OF A PARTIAL PARCEL OF LAND FROM CL LIMITED COMMERCIAL TO RS-2 RESIDENTIAL AND A PARCEL OF LAND FROM RS-1 RESIDENTIAL TO RS-2 RESIDENTIAL; BOTH PARCELS LOCATED AT 2426 S JEFFERSON AVENUE

COMMENTS

Police Chief Harrison- reported that officers responded to an alarm at Harke Park where underage drinking and property damage was taking place. He said eleven people were identified and were under investigation and one was taken to the hospital for a medical emergency. Chief Harrison said he wanted to mention that the park strategy of securing our parks to align with the council goal to make Lebanon safe and have well-maintained park facilities enabled the City's officers to catch and prosecute those involved and potentially saved one person's life.

Public Works Director Richard Shockley- reported that the City was awarded the MoDOT TAP Grant for sidewalks over Exit 127 from Ivey Lane to Morgan Road.


