CITY COUNCIL MEETING MINUTES
September 9, 2024

BE IT REMEMBERED that the Council of the City of Lebanon, Missouri, met in Regular Session on September 9, 2024, at 6:43 p.m. in the Council Chambers at City Hall located at 401 South Jefferson.

ROLL CALL AND DECLARATION OF A QUORUM

Upon roll call, the following Officers were present: Gib Adkins, Sheila Mitchell, Dan Mizell, Randy Wall, Chuck Jordan, Bob Garner, and Mayor Carr. Absent: Mike Evans and Jeff Mutchler.

A quorum was declared.

INVOCATION AND PLEDGE OF ALLEGIANCE

The invocation was given by Don Anderson, an Emergency Services Chaplain, followed by the pledge of allegiance.

PUBLIC COMMENTS

Robert Young- asked if the route proposed for the Share Your Christmas Parade would be grandfathered in and not be subject to the routes approved by the Chief of Police as noted in Council Bill No. 6747 being second read this evening amending code language related to parade permits. Police Chief Harrison explained to Mr. Young that he had already discussed this matter with him, and he would need to follow the new route. Chief Harrison stated he would be glad to speak to him outside of the meeting to again go over it with him.

DISCUSSIONS AND PRESENTATIONS

Constitution Week Proclamation

Mayor Carr read the following proclamation aloud and declared September 17 through 23 to be "Constitution Week." He then presented the proclamation to Sarah Stewart who was representing the Daughters of the American Revolution.

WHEREAS: The Constitution of the United States of America, the guardian of our liberties, embodies the principles of limited government in a Republic dedicated to rule by law; and

WHEREAS: September 17, 2024, marks the two hundred and thirty-seventh anniversary of the framing of the Constitution of the United States of America by the Constitutional Convention; and

WHEREAS: It is fitting and proper to accord official recognition to this magnificent document and its memorable anniversary, and to the patriotic celebrations which will commemorate it; and

WHEREAS: Public Law 915 guarantees the issuing of a proclamation each year by the President of the United States of America designating September 17 through 23 as Constitution Week; and

NOW, THEREFORE I, Jared Carr, by virtue of the authority vested in me as Mayor of the City of Lebanon in the State of Missouri, do hereby proclaim the week of September 17 through 23 as

CONSTITUTION WEEK

and ask our citizens to reaffirm the ideals that the Framers of the Constitution had in 1787 by vigilantly protecting the freedoms guaranteed to us through this guardian of our liberties.

IN WITNESS WHEREOF, I have hereunto set my hand and caused the Seal of the City to be affixed this 9th day of September of the year of our Lord two thousand twenty-four.

Councilman Jordan- stated he enjoyed this evening's meeting, and the discussions were good.




Mayor Carr- announced the upcoming meeting scheduled and shared the City's fall newsletter would soon be distributed.
