



ENERGY STAR® Programmable Thermostat Rebate Application Form

Properly using a programmable thermostat in your home is one of the easiest ways to save energy, money, and help fight global warming. An ENERGY STAR qualified programmable thermostat helps make it easy for you to save money while regulating your home's temperature all year long. City of Lebanon's electric customers are eligible for a \$15 rebate credit toward their utility bill after the purchase and installation of an ENERGY STAR qualified Programmable Thermostat.

The purpose of this program is to reduce the cost of the thermostats making them affordable to as many customers as possible, and to increase awareness of energy efficient products. In many cases, the purchase and installation will result in long-term energy savings and increased comfort.

Rebates are for ENERGY STAR qualified programmable thermostats purchased and installed. Certain restrictions may apply. Please read the Guidelines for more details.

Guidelines ·

Rebates are only available to City of Lebanon electric customers who are the customers of record for active non-delinquent accounts.

- Thermostats must be ENERGY STAR® qualified and bear the ENERGY STAR® seal.
- Rebate will not exceed the thermostat purchase price.
- To receive rebate credit, the ENERGY STAR® qualified programmable thermostat must be purchased and installed. Rebates are limited to two per residential customer and up to five per commercial and multi-family customers, during each program year (October through September). Rebates are awarded on a first-come, first-serve basis until program funds have been depleted.
- Copies of installer invoices and/or itemized purchase receipts, original programmable thermostat UPC code (unless contractor-installed), and the model number must be submitted with a completed application form.
- Failure to provide required information may result in denial of rebate.
- Participants in this program must agree to properly dispose of old thermostats containing mercury.
- City of Lebanon reserves the right to inspect the installed rebated material. If such site does not have the qualifying equipment installed, the rebate may be charged back to the electric or natural gas account.
- City of Lebanon reserves the right to amend or discontinue this program without notice.

Thermostat Disposal Information: If you are replacing a conventional thermostat that has a mercury switch, be careful not to break the tube that holds this substance. As a Lebanon/Laclede County resident, you may use the services of the City of Lebanon's Household Chemical Collection Center free of charge. Hours of acceptance are Monday - Friday from: 1:00 PM - 4:30 PM One Saturday a month 9:00 AM - 2:00 PM No Holidays.
