### What is WEATHERIZATION?

Weatherization means to make cost-effective, energy-efficient home improvements and upgrade with expectations of:

- \* Reducing energy usage while saving on future utility costs
- \* Increased indoor comfort and
- \* Potentially better health for its inhabitants

### INCENTIVES available to WEATHERIZE!

This program is intended for Lebanon utility customers\* with high utility bills, yet they remain uncomfortable during extreme peak seasons. Lebanon Weatherization Works program offers up to \$1,750 in rebates for completed weatherization improvement efforts\*.

## Up to \$1,750 in Rebate Incentives

### Home Energy Audit\*;

Owner pays \$50

Lebanon pays remainder of fee

\* Audit determines eligibility of Weatherization Measures .

**Caulking & Weather-stripping;**  
COL pays up to \$200 at 15¢/Sq Ft or 50% of total costs.

**Exterior Doors, Windows, and Ductwork;**  
COL pays up to \$800 at 90¢/Sq Ft or 50% of total costs.

**Insulation Efforts;**  
COL pays up to \$750.00 at 50¢/Sq Ft or 50% of total costs.

## WHO is the ideal client?

Lebanon's Weatherization Works program is available to both owner and renter occupied homes. However, the homeowner must be the applicant for this incentive program.

## Six Phases of Weatherization Program

### Assessment Phase (Owner/Lebanon):

Homeowner answers a series of tabletop assessment questions relating to; the home, the home's dwellers, and the homeowners personal financial status. This assessment helps to verify, qualify and determine the most suitable weatherization program(s).

### Investigation (by Owner) Phase:

After approval and committing to Lebanon's Weatherization Works incentive program, the homeowner schedules and completes a home audit performed by a certified technician. An audit report is provided to both the homeowner and Lebanon's weatherization specialist. The homeowner chooses measures recommended by the audit report, and determines the best manner in which to complete the repairs and/or upgrades.

### Planning Phase (Owner/Lebanon):

Homeowner and Weatherization specialist discuss audit and rebate opportunities for improvements.

### Implementation Phase (Owner):

Homeowner chooses to complete improvements themselves (only material costs will be reimbursed). Or homeowner obtains quotes and chooses a reputable contractor most suitable to complete the necessary improvements.

### Closeout Phase (Owner/Lebanon):

Once improvement measures are complete, the homeowner submits to Lebanon a request to be reimbursed, including receipts. Lebanon will schedule a final walk-thru, with the homeowner, to complete a visual verification and document completed measures. Upon approval Lebanon will release the appropriate funds .

### Performance Phase (Lebanon):

Lebanon begins monitoring utility usage of weatherized home and reports findings to Owner upon request.
